## Air Tour Terms & Conditions

### Payments and Scheduling

- Payment is required to schedule your flight. Payments may be made over the phone or in person. We accept cash and all major credit cards.
- For sunset flights, plan to arrive at least 1-hour before the published sunset for that day. Sunset times can be found here: **Sunset Data for Hagerstown**
- Scheduling is on a first-come first-served basis
- Walk-ins are accepted contingent on weather, and plane and pilot availability. Reservations are highly recommended.

### Cancellations

- Cancellation notice must be giving 24-hours prior to avoid additional charges.
- V1 Aeronautics may cancel a flight at any time if the safety of the flight is ever in doubt for any reason. For weather related cancellations, V1 Aeronautics will do its best to notify the customer as far in advance as possible. Given the changing nature of weather, some flights might be canceled only hours prior.
- All canceled flights will be rescheduled at a date and time agreed upon by the customer and V1 Aeronautics.

### Refunds

- All payments are non-refundable

### Weather

- All flights are subject to basic weather minimums. Minimums are defined as a 3000' cloud base, at least 6 miles visibility, and wind velocity at or below 25mph.

### Safety and Comfort

- No person will be allowed to board the aircraft if visibly intoxicated
- Restroom facilities are available in the Rider Jet Center lobby
- Please let your pilot know if you have been SCUBA diving in the last 48-hours
- Please let your pilot know if you get seasick or you are prone to car sickness
- Your pilot is the final authority on the flight. He may cancel the flight any time he feels safety is a concern.
- At this time, we do not allow children to fly who would normally require a car seat in a motor vehicle.
